Legend of the Kirkin' o' the Tartans (Some historians doubt it, but it makes a good tale)

Legend tells the story of the tiny pieces of tartan hidden in a persons clothing on the day of blessings. After the Scots were defeated at Culloden Moors, in 1746 the English decreed that the ways and culture of the Scots were forbidden. This included the wearing of one's tartan. The Scots were fervent Christians and very canny in that they clung to their ancient traditions in secret by putting them underground. The Kirk (church) was their place of worship and one Sunday out of the year they would hide a piece of their tartan in their clothing for the blessing to be given that day. While the minister pronounced the blessing on all tartans the Scots would silently pledge their loyalty and respect to their old traditions.

Proposed changes to the Rules

Over the last few months the committee has been going through our rules and these are the alterations we would like to adopt. We will be voting on them at our general meeting on the 31st August at the picnic.

Existing Rule:

2.1 To act to firmly establish the Clan Forsyth Society of Australia by stimulating and co-operating with individual families and groups of Forsyth descendents throughout Queensland and other States of Australia.

Change:

2.1 To act to continually promote the Clan Forsyth Society of Australia by stimulating and co-operating with individual families and groups of Forsyth descendents throughout Queensland and other States of Australia.

Existing Rule:

4.3 There shall be the following types of membership:

Persons of or over the age of 18 years. Ordinary:

Family: Joint membership, if desired, of spouses or parent/s and

children.

Junior: Persons under the age of 18 years.

To be bestowed on such persons as the Committee shall Honorary:

Each member (other than junior) or, in the case of family membership,

each family shall be entitled to one vote at general meetings

Change:

Ordinary: Persons of or over the age of 18 years.

Joint Membership: Couple

Life Member: A member who in the opinion of the Committee has

rendered dedicated lengthy or special service to the Society.

Note family, junior and honorary deleted.

New Rule 4.4 Each of the following members is entitled to one (1) vote at any General

Meeting of the Society. Ordinary member

- (b) Joint member one vote each
- (c) Life member

(c) SECRETARY/TREASURER

- (i) The Secretary/Treasurer shall keep complete minutes of general meetings and Committee meetings;
- (ii) The Secretary/Treasurer shall record all correspondence and keep records of social gatherings and other events of interest to the Society;
- (iii) The Secretary/Treasurer shall be responsible for the day to day operation and recording of the Society's financial transactions;
- (iv) The Secretary/Treasurer shall keep all financial records required to be kept pursuant to these Rules;
- (v) The Secretary/Treasurer shall report to each Annual General Meeting and Committee meeting upon the financial position of the Society and shall obtain approval for payments made or to be made by the Society.

Change: Splitting the Secretary/Treasurer position thereby doing away with assistant Secretary/Treasurer

(c) SECRETARY

- (i) The Secretary shall keep complete minutes of general meetings and Committee meetings;
- (ii) The Secretary shall record all correspondence and keep records of social gatherings and other events of interest to the Society;

(d) TREASURER

- (i) The Treasurer shall be responsible for the day to day operation and recording of the Society's financial transactions;
- (ii) The Treasurer shall keep all financial records required to be kept pursuant to these Rules;
- (iii) The Treasurer shall report to each Annual General Meeting and Committee meeting upon the financial position of the Society and shall obtain approval for payments made or to be made by the Society.

Existing Rule:

7.2 The Committee shall be made up of not less than seven (7) and not more than nine (9) persons, all of whom shall be members of the Society. The President, Vice President and Secretary/Treasurer shall be members of the Committee.

Change:

7.2 The Committee shall be made up of not less than seven (7) and not more than eleven (11) persons, all of whom shall be members of the Society. The President, Vice President, Secretary and Treasurer shall be members of the Committee.

Existing Rule:

8.6 Minutes:

The Chairman of each meeting shall cause minutes of that meeting to be kept and made available to the Secretary/Treasurer for entry

in a minute book. The minutes shall be signed by the Chairman of the next succeeding general meeting or committee meeting as the case may be.

Change:

8.6 Minutes:

The Chairman of each meeting shall cause minutes of that meeting to be kept and made available to the Secretary for entry in a minute book. The minutes shall be signed by the Chairman of the next succeeding general meeting or committee meeting as the case may be.

Existing Rule:

9.2 A reconciliation and statement of receipts and payments shall be prepared by the Secretary/Treasurer before every Annual General Meeting and shall be presented to the Annual General Meeting for approval.

Change:

9.2 A reconciliation and statement of receipts and payments shall be prepared by the Treasurer before every Annual General Meeting and shall be presented to the Annual General Meeting for approval.

Anywhere that 'he or him' is mentioned should be changed to him/her, he/she
