
Dear Doris, perhaps we may call you "Dossie",

# Progress on Incorporation of the Clan Forsyth Queensland Branch

#### **General Meeting**

On Saturday 25<sup>th</sup> July 2015 a "General meeting" was held to discuss the "Special Resolution" to consider the question of incorporation for the Clan Forsyth Society of Australia (Queensland Branch). The quorum of members who attended have voted unanimously in favour of changing the legal structure of the organisation to an incorporated association under Queensland law.

In addition to lodging our application with the Queensland Department of Fair Trading (**DOFT**) to incorporate our association, the meeting also resolved two additional items:

- 1. To firstly to adopt a new constitution based on the DOFT recommended Model Constitution.
- 2. Secondly, to make the Clan's objectives more aligned to those that were achievable, based upon the current resources and skill sets of our membership. This has meant that some aspirational objectives such as obtaining employment for unemployed clan members have been removed from our previously stated objectives. The net result being that of the 12 original objectives, has now been streamlined to base of 10 only.

Our application was submitted last Monday in Ipswich and processed on 29<sup>th</sup> July by DOFT in Brisbane. I spoke with the Brisbane office by phone on Tuesday to clarify our relationship to the Clan Forsyth Society of Australia. I was told I would be advised by phone or post as the application progressed.

#### Names of Incorporated Organisation Initially Rejected

In moving to an incorporated association we had hoped to cause the least disruption possible by simply adding the abbreviation "Inc." after our existing name.

This however was not possible and in a response from DOFT was received on Friday 31<sup>st</sup> by post, regarding our application and their assessment, it was explained that the use of the word "Branch" in our name is somewhat of a stumbling block and a possible <u>permanent</u> impediment. This was because the Australian Society, to which our name infers we are a branch of, remains an unincorporated body.

## Queensland Branch a wholly autonomous body

I had previous argued in the initial application that the Queensland Branch was a wholly autonomous body that was affiliated in name only with "Clan Forsyth Society of Australia", which referred to what was essentially the NSW branch of the Society and that we had for the last 35 years simply used the term "Queensland Branch" to differentiate ourselves from NSW and any other State branches.

It was argued that we as group performed the following:

- We conducted our own AGM's
- We maintain our own bank accounts
- Performed our own fund raising
- Held all membership records
- Held our own public liability policy
- Executed our own program and agenda.

The following was also similarly true:

- We provided no input in Policy or procedure to a national body
- We made NO financial contribution to a national body
- We elected no representatives
- We made no other representation to a Clan Forsyth Society of Australia.

However, after making this submission, it would appear that this explanation has been rejected in that despite our use of the word branch in our name for the last 35 years, that for us to become incorporated in Queensland, we cannot infer by name, that we are the branch of any Australian body if the parent body (the NSW branch) is unincorporated.

The use of the word "Branch" is a reserved legal term in much the same way terms such as "Limited" or "Company" are similarly reserved in their usage.

We enquired if something similar to – **Clan Forsyth Society of Queensland Inc**. would be OK and we were advised that it would and that I should now just come up with two other an email him them over the weekend, and it would be attended to first thing on Monday.

#### **Granting of Incorporation to our Association.**

After we submitted the above name along with two other alternatives our application to incorporate was approved the following Friday and on 7<sup>th</sup> August 2015, the Department of Justice issued a Certificate of Incorporation.

The following is a report regarding a review and amendment of the society's Public Liability coverage through our insurer (FIS) in Boonah.

#### **DOCUMENTS**

In early July FIS was asked to provide a quotation for the renewal of our PL insurance, that would allow us to have multiple activities throughout the year and allow for a realistic number of persons attending these events.

I have been advised that the previous quotation \$647-00 in 2014 was based on ALL members being able to attend all events. Hence the previous committee's decision reduce both the cost (\$460-00 in 2014) along with the number of events back to the AGM and the Dinner only.

After some "To-ing and Fro-ing" between FIS, their underwriter and myself, they eventually advised me on the 5<sup>th</sup> June, that they believed we would be able to include multiple additional activities. They even suggested we could hold multiple dinners each year without impacting our risk profile. However let's not even go there!

In these discussions back in early June, the only real limitations they proposed were working bees, that involved the use of power tools and alcohol based events (i.e. a drinks evening).

I would have been happy to accept those limitations and I would be happy to accept these exclusions, but I would certainly invite your comment on this topic. In future years should we choose we can still whipper-snip, chainsaw and slash through every cemetery and public reserve with 200km of Peak Crossing and all while still holding a cold beer or chilled wine in the other hand should we wish – we will just pay a lot more for our liability coverage.

While there was some talk in the "corridors of underwriting" at FIS, that reduce the cost by excluding the "SENIOR CITIZENS", I however remained steadfast and suggested we would rather lose the "POWER TOOLS" and "ALCOHOL".

On the serious side – that is really going to mean that all events in future are going to need to be BYO – however I really cannot see that as a major sticking issue.

#### **HOW MUCH WILL THESE EXTRA EVENTS COST?**

So at the early stages of this discussion the big question that could not be definitely answered was, excluding all those cemetery slashing events, just how much was it to cost to renew the policy in 2015 which would include these additional events?

The answer arrived in the post a full 30 days prior to the renewal date so that we could make funding arrangements if required. Now given all of the above ... along with factoring for CPI increased I felt the increase from \$460 in 2014 to the princely sum of \$470 for 2015 was to my mind a more than reasonable expense.

#### THE ONLY OTHER ISSUE ...

The other item I noted there was the new policy's requirement that there be a first-aid kit available at all organized events. This may have already been a previous requirement however if we do not as a group own and maintain such an item —I suggest we turn our discussions to this topic also. I will leave this topic open to those who are more adequately qualified to provide opinion on this issue.

However from my experience with Public Labiality insurers, I would also suggest that along with the first aid kit that we also maintain an incident log (essentially a "Dux" exercise book), to record ALL occasion who when where and why and person was treated from the kit.

Additionally I would also believe that we would be required to additionally advise our insurer of such an event also. This advice could be as simple as an email or even a standard form recording the same details as listed above.

# A "1-in-100" Year Event Doris Matheson Turns 100 – 10<sup>th</sup> August 2015

At a small function attended by approximately 50 family and close friends, Doris Matheson (a.k.a. Dos, Dorrie, Dossie) formerly of Flinders, South Port and now Caboolture, celebrated her 100<sup>th</sup> Birthday on Saturday 8<sup>th</sup> August 2015.

#### A remarkable life

Doris May Matheson (nee Forsyth) was born in Ipswich on 10th August 1915 to Hector and Isabel Forsyth. She was the second of her parent's child of nine children. She lived in a home in Peak Crossing/Flinders where the family lived while her father worked a small holding a few miles outside of the town.

She was educated a Peak Crossing School. Her later schooling cease abruptly when as the oldest daughter she was require care for her mother who had become ill through child birth.

Her first paid employment was at the age of 16 when she was employed as a domestic assistant for the Winks Family of Peak Crossing.

At the age of 20 she met Leonard James Matheson, a road worker when he attended a dance at the Peak Crossing Memorial Hall while he was encamped nearby and was working on the upgrade of Peak Crossing Boonah Road.

The couple married in 1935 and his new wife accompanied Leonard, who was known to all simply as "Blue", to Toowoomba

along with many other road side camp sites were their first home little more than flap of canvas for the next five years of the couples married life.

Their first daughter Dulcie and later their son Allan (aka Boyd) were both born while the family were away from Peak Crossing on Road Camps.

Raising two small children in a tent and cooking on an open fire must certainly have presented its challenges to Doris. However it was not until the after the outbreak of the World War II the family returned to Flinders and took up residence in what was to be the family home for the next four decades.

Blue enlisted in the Air Force where he drove transports. After the War Blue purchased his first of several trucks in 1946 and he recommenced his contracting work with Main Roads. However being settled in a fixed home during those war years there were to be no more Road Camps

for Doris. Blue was then forced to stay at some far off road camp during the week and travel home to Flinders at weekends for the next several years.

He passed away suddenly in 1961 at the age of 48.

Tragedy again struck the family in 1966 with the loss of Doris's only daughter Dulcie who passed away at age of 30 leaving her husband Brian and two small children.

Doris remained in her home at Flinders with her recently windowed mother for several year until she moved to Southport in 1971 where two of her sisters (Enid Waters and Bethel Gordon) were then living.

During her time on the Gold Coast she and two of her sisters met the Clan Chief Alistair Forsyth, along with other local representatives of Forsyth families, when he visited Australia in the late 1970's after their Clan had been reinstated.

Doris and her sisters were always regular supporters and attendees of Clan functions. She always enjoyed contributing by baking for fundraising and initiated events such as *the "Bring-and-Buy*" stall at the annual picnic in her beloved Peak Crossing.

She remained in her own home at Prince Street Southport until at the age of 98 and with failing eyesight she was compelled to seek assisted living arrangements, at a nursing home closer to her family, who were now located at Bribie Island.

Many of children both young and old were disappointed to learn that this would be the last year that there much beloved Jumping Castle would be available as the owner was being forced to dispose of it to his declining health


After the adult's meeting concluded at around midday everyone young and old alike adjoined to hall for an




On several occasions in previous years the Clan has conducted on a number of occasions well attended family camping weekends at a number of locations.

# Family History Lyndall Hill - Historian/Genealogist James Imlay Forsyth



Thanks to the information from James Grainger (M.D.S; F.R.A.C.D.S; F.I.C.D; F.A.D.I; F.P.F.A) about his grandfather James Imlay FORSYTH. James is a regular at the annual Clan Forsyth Dinner and is a distinguished dental surgeon and dental educator at University of Sydney and Griffith University. He lives at Kingscliff.

We thank him for sharing his Forsyth heritage with us.

James was the oldest son of four children born to John Forsyth (1829-1875) and his wife Jamesina Jacobina McLaren (1837 – 1928). John Forsyth had been born in Parramatta, NSW, and Jamesina had been born in Barony, Glasgow, Scotland. (It is interesting to note the feminine version of traditional male names that were given to Jamesina). They were married on 12<sup>th</sup> October 1864. However John died aged 46 in 1875, leaving four children and Jamesina as a widow for 53 years.

James was born on 5<sup>th</sup> October 1865 at Jasper's Bush, Shoalhaven. He married Ann Jane Steel (born Paddington in 1868 – died 1929) on 3 January in 1895 in Woollahra, NSW. James' siblings were William Ernest (1863-1939); John P McLaren (1870-1925) and May (Daisy) Cumming Forsyth (1874-1945).

James was the headmaster of Beecroft Public School from 1915-1924, presumably living at the headmaster's residence. He purchased the beautiful heritage home a, *Twyford*, on Miriam Rd and the names was changed to *Glenorchy*. James lived there until his death in 1937. The house passed firstly to his daughter Janet until her death in 1958, and then to her sister Ina, married to Keith Grainger, and the house was sold in 1959. This meant the end of 34 years of Forsyth occupancy.



He and Ann had five children:

- 1. Robert Steel Forsyth 1895-1916
- 2. Daisy May Isabel Forsyth 1898-1979
- 3. John Stuart Alston Forsyth 1900-1947
- 4. Janet Ailsa Comyn Forsyth 1901-1958
- 5. Ina Evelyn Ruth Forsyth 1905-1986

James died on 26<sup>th</sup> September 1937 at West Ryde, Sydney, and is buried in the Waverley Cemetery – General Special Section with his wife Ann and other family. The following funeral notice is from newspaper file in Trove.

# Local History By Val Ashton - Clan President The "Forsyth Pioneer" Trail and Tour by Bus

# A heritage and history field trip.

For a number of years at our annual picnic there has been a recurring discussion regarding a tour of a number of the original Forsyth Pioneer home sites that lay in close proximity to the Peak Crossing, Flinders, Harrisville and Limestone Ridges area.

#### Maps of Forsyth Pioneer Home Sites.

This year with the assistance of our Clan Genealogist Mrs Lyndall Hill and her husband Murray have produced a small map the covers a number of the more relevant sites of historic value and interest.

This tour both starts and concludes at the site of our annual picnic in Peak Crossing and should only take just a little over 60 to 90 minutes to complete. However as we all age, the Clan committee has recognized the difficulty that may exist for some of our more senior members in negotiating such a route in their own private vehicles.



We have therefore negotiated with a private bus operator for the tentative hire of small commuter bus that would allow for most members to complete this tour in relative comfort and safety. One our members has already volunteered to act as our driver and as such we only need to cover the cost of mileage and vehicle hire.

It is anticipated that this cost would be approximately \$7 to \$10 per person, (depending on numbers). This may even be an excellent opportunity to show children or even grandchildren locations that hold some special significance to your branch of the family.

#### Indication of your interest

Unfortunately there is a reasonable outlay associated with cost of providing the bus as a service to our membership and this being our first attempt arranging such a tour, we would hope to obtain some indication of interest for this tour. We would there ask if you feel that tour would be interest and value to yourself and your family if you could advise us of your interest and number or attendees so that an appropriate booking can be made.

A final date for this field trip has as yet not been finalised, but a tentative timing of mid to late October has been suggested. This topic will be listed for discussion at the Clan Picnic on 30<sup>th</sup> August 2015, so that we can field a wide variety of opinion on this topic.

# **WALKING HADRIAN'S WALL - FROM SEA TO SEA**

Some may think that there has always been a divide between the people of England and those who are the descendant of the Clans and tribes who originate further northern most regions of that island.

These divides extend way beyond the subtle differences in language, dress and culture.

In fact the divide has taken a physical form in the shape of a 2000 years old wall, originally constructed by the Roman Emperor Hadrian for the original purpose of establishing and maintaining the control of empire.in

Known as Hadrian's Wall (Latin: Vallum Aelium), also called the Roman Wall, Picts' Wall, or Vallum Hadriani, as a defensive fortification in the Roman province of Britannia, begun in 122 AD during the rule of emperor Hadrian. It ran between the River Tyne and the Solway Firth. It had a stone base and a stone wall.

#### Probing the wall

In June 2015 A.D. two members of Clan Forsyth Queensland (Veronica Forsyth, Annie –Rose Forsyth two other close friends of Celtic origins) managed to trace the wall along its length from sea to sea.

The walk was completed in the middle of the blistering Northern English summer with walking temperatures reaching as high as 25 Degrees C in between showers, on some days. (This was sheer madness - many of the locals thought).

Presumably our Queensland walkers either felt compelled to probe for some defensive weakness overlooked by those crafty Brittan's or potentially just to take in the local scenery.

#### **World Heritage Site**

Hadrian's Wall was declared a World Heritage Site in 1987, and in 2005 it became part of the transnational "Frontiers of the Roman Empire" World Heritage Site which also includes sites in Germany.

#### **Hadrian's Wall Path**


The walk is some 140 km (84 miles) from coast to coast following the World Heritage Site of Hadrian's Wall, past Roman settlements and forts. There's history every step of the way, and cosy pubs, bustling market towns and great views too.

Our brave adventurers decided that walking self-guided was the way to go and they then set about walking the whole of the National Trail. Most folk come for about a week (6 or 7 days walking @ about 20 Km/day) and a few intrepid adventures have completed the walk/run in a few days.

#### **Details of the National Trail footpath**

In 2003, a National Trail footpath was opened that follows the line of the wall from Wallsend to Bownesson Solway. Because of the fragile landscape, walkers are asked to follow the path only in summer

# The Doris Matheson's Collection Of Famous Sponge Cake Recipes.

# **Doris's Sponge Base**

#### **Ingredients:**

- 3 eggs, separated
- pinch salt
- 1/4 teaspoon vanilla essence
- 1/2 cup castor sugar
- 2/3 cup Fielders Cornflour
- 1 slightly rounded tablespoon White Wings Plain Flour
- 1 level teaspoon Aunt Mary's Baking Powder

#### Method:

- 1. If you have a wood stove laying around the kitchen, then it will probably best to use it. However, if you don't, then you can also use a normal electric or Gas oven, to produce a reasonable result. Simply Pre-heat oven 190 degree C conventional/170 degree fan forced. Beat egg whites with salt until soft peaks form.
- 2. Gradually beat in sugar, a little at a time then continue beating until stiff. Add egg yolks and vanilla essence, beat until combined.
- 3. Sift together 3 times cornflour, plain flour and baking powder, then add to egg mixture. Carefully and lightly fold mixture through using a wooden spoon or spatula. DO NOT STIR.
- 4. Divide batter between two greased and floured 20 cm round sandwich pans and bake 15 20 minutes.

<u>Note:</u> When making a large sponge for a party use one quantity of mixture for each cake and bake in larger tins instead of halving mixture between sandwich pans
